

ORDINANCE NO. 2024-01

AN ORDINANCE abating the tax heretofore levied for the year 20~~21~~²³ to pay debt service on Taxable General Obligation Bonds (Alternate Revenue Source), Series 2021, of the Bensenville Fire Protection District No. 2, DuPage and Cook Counties, Illinois.

WHEREAS, the Board of Trustees (the "*Board*") of the Bensenville Fire Protection District No. 2, DuPage and Cook Counties, Illinois (the "*District*"), by an ordinance adopted on the 27th day of May, 2021 (as supplemented by a related notification of sale, the "*Bond Ordinance*"), did provide for the issue of Taxable General Obligation Bonds (Alternate Revenue Source), Series 2021 (the "*Bonds*"), and for the levy of a direct annual tax sufficient to pay principal and interest on the Bonds (the "*Pledged Taxes*"); and

WHEREAS, the Board hereby determines that (1) the District has levied taxes for firefighters' pension and/or corporate purposes for levy year 2023 (such levy or levies, collectively, being the "*Pledged Revenues Levy*") and filed the same with the County Clerks of DuPage and Cook Counties, Illinois (the "*County Clerks*"); (2) the Pledged Revenues Levy for levy year 2023 is not less than the amount of principal of and interest on the Bonds otherwise payable from the Pledged Taxes levied for levy year 2023; and (3) the amount of principal of and interest otherwise payable from such Pledged Taxes will not exceed the District's "aggregate extension" for levy year 2023 as calculated by the County Clerks in accordance with the Limitation Law (as defined in the Bond Ordinance); and

WHEREAS, the Board hereby further determines that it is necessary and desirable that the Pledged Taxes levied for levy year 2023 be abated in their entirety:

NOW, THEREFORE, Be It Ordained by the Board of Trustees of the Bensenville Fire Protection District No. 2, DuPage and Cook Counties, Illinois, as follows:

Section 1. Abatement of Tax. The Pledged Taxes levied for levy year 2023 are hereby abated in their entirety.

Section 2. Filing of Ordinance. Forthwith upon the adoption of this Ordinance, the Secretary of the Board shall file a certified copy hereof with the County Clerks and it shall be the duty of the County Clerks to abate the Pledged Taxes levied for levy year 2023 in accordance with the provisions hereof.

Section 3. Effective Date. This ordinance shall be in full force and effect upon its adoption.
