

ORDINANCE NO. 2024-02

**AN ORDINANCE INCREASING THE NUMBER OF TRUSTEES  
OF THE BENSENVILLE FIRE PROTECTION DISTRICT FROM  
THREE MEMBERS TO FIVE MEMBERS**

**WHEREAS**, the Bensenville Fire Protection District No. 2, DuPage and Cook Counties, Illinois (the "District") is a fire protection district duly organized under the laws of the State of Illinois; and

**WHEREAS**, the Board of Trustees (the "Board") of the District has full power to pass all necessary ordinances and rules for the proper management and conduct of District business pursuant to 70 ILCS 705/6; and

**WHEREAS**, the Board currently consists of three members; and

**WHEREAS**, the Illinois Fire Protection District Act grants the Board the authority to establish a five member Board of Trustees by adopting an ordinance to that effect (70ILCS 705/4.01); and

**WHEREAS**, Board finds it is in the best interest of the District to increase the number of trustees from three to five members.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Trustees of the Bensenville Fire Protection District No. 2, DuPage and Cook Counties, Illinois as follows:

**Section One**: The Board of Trustees of the District hereby provides for the establishment of a five-member board of trustees.

**Section Two**: The Administrator and District attorney are authorized and directed to file a certified copy of this ordinance with the agency having appointment power for Trustees of the District.

**Section Three**: The provisions of this Ordinance shall be in full force and effect upon the adoption and signing of the Ordinance.
