- a) Discussion of new hires and current process status
 - i) Background checks have been returned and additional information has been requested for the candidate at the top of the current hiring list. District is waiting on a response to be received to a FOIA request regarding the candidate's resignation from the McHenry FPD
 - ii) Discussion on Candidate Biagi background-check.
 - iii) Commissioners discussed potential criteria to decline conditional offer to top candidate upon the return of the FOIA request
 - 1) Tardiness would not be sufficient to pass
 - 2) Dishonesty would be sufficient to pass
 - 3) Commission discussed interview feedback for the two candidates and had more positive response to the second candidate
 - 4) Commissioner Fischer requested that material of the FOIA request be forwarded to the Commissioners before any decision is made

- 5) Upon return of the FOIA request if Chief deems any material to be potentially detrimental, disqualification letter will be sent to the first candidate and conditional offer will be prepared for the second
- 6) Commissioner Coniglio made a motion to have Chief review Candidate one's personnel file and pass if the information meets the criteria specified by the Commission. Commissioner Fischer second. Roll call vote: Commissioner Coniglio, aye; Commissioner Fischer, aye; Commissioner Rott, aye. 3 ayes, 0 nays, 0 abstain. Approved.


- Two additional Trustees were appointed at the last Board of Trustees meeting
