A RESOLUTION DECLARING SURPLUS PROPERTY AND AUTHORIZING THE SALE, DONATION, OR DISPOSAL OF SURPLUS PROPERTY

WHEREAS, the Board of Trustees of the Bensenville Fire Protection District (the "District"), DuPage County, Illinois, has the authority pursuant to 70 ILCS 705-10a to sell, donate, or dispose of personal property no longer needed for fire protection or emergency medical services; and

<u>Section One</u>: The District hereby finds that the personal property identified on **EXHIBIT A** attached hereto and made a part hereof is no longer needed for Fire/EMS purposes and is declared to be surplus.

Section Two: The identified surplus property shall be sold "AS IS". In particular, THE SELLER MAKES NO WARRANTIES OR REPRESENTATIONS EXPRESSED OR IMPLIED ABOUT THE PERFORMANCE ABILITY OF THE SUBJECT PROPERTY, ABOUT ITS PRESENT STATE OF REPAIR, ABOUT ITS CONDITION OR MAINTENANCE, ITS MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE.

Section Three: The sale shall be contingent upon agreement by the Buyer that:

- a) The property will be for the sole use and purposes of the Buyer, and
- b) The Buyer properly executes the Indemnity and Hold Harmless Agreement substantially in the form contained in EXHIBIT B attached hereto.
- c) The Buyer will remove all Bensenville Fire Protection District lettering from property before any public display or use of property is allowed.
